PARTICIPANT AGREEMENT

RISKS EXIST: The Alaska Discovery Foundation, Inc., doing business as Discovery Southeast, operates programs taking students outdoors. Discovery Southeast aims to provide programs promoting lifelong physical and mental health and fitness. There are, however, risks involved. We are often physically active in Juneau's rugged terrain, with inclement weather and elements of wilderness—such as wind, rain, wild animals, and moving water. We usually go off trail, which means we are quickly exposed to wild environments. We sometimes play games, resulting in children who are active and excited. We also travel through and experience non-wild areas: for example, we sometimes travel by 15 passenger van or bus, or walk along a city street, and offer programs in city parks or public spaces where other people and pets are present. Further, Discovery Southeast staff are human and can make mistakes, leading to injury even in a seemingly safe situation.
